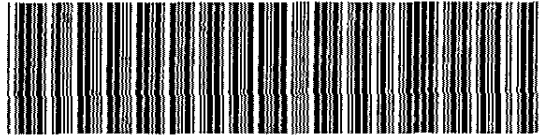

**ARTICLES OF ORGANIZATION OF

The undersigned, being authorized to execute and file these Articles, hereby certifies that:

ARTICLE I - Name:

The name of the Limited Liability Company is: **K & P INVESTMENTS, LLC** (hereinafter the "Company").

ARTICLE VIII - Registered Agent and Office:


