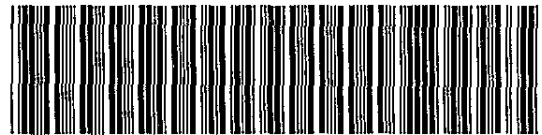


1. **Name.** The name of the limited liability company is Raeford Development, LLC.
