ARTICLES OF ORGANIZATION

OF

G & S MOTORSPORTS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, <u>Florida Statutes</u>, Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be: G & S MOTORSPORTS, LLC.

ARTICLE II -- ADDRESS

The street address of the principal office and mailing address of this Company is 220 Manor Drive, Bartow, FL 33830.

ARTICLE III -- DURATION
