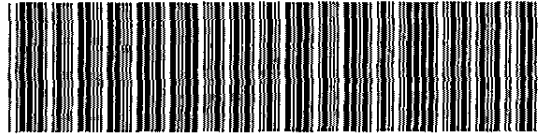



The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be: G & S MOTORSPORTS, LLC.

**ARTICLE II -- ADDRESS**

The street address of the principal office and mailing address of this Company is 220 Manor Drive, Bartow, FL 33830.

**ARTICLE III -- DURATION**

The Company shall commence its existence on the date these articles of organization are filed by the Florida Department of State or on another effective date, if specified. The Company's existence shall be perpetual unless the Company is dissolved earlier as provided in these articles of organization or in the Operating Agreement.

**ARTICLE IV -- REGISTERED OFFICE AND AGENT**

The name and street address of the registered agent of the Company in the state of Florida is George T. Dunlap, III, 245 South Central Avenue, Bartow, Florida 33830.

**ARTICLE V -- ADMISSION OF NEW MEMBERS**

Except as set forth in the Operating Agreement, no additional members shall be admitted to the Company except with the written consent of a majority in interest of the members of the

Company and on the terms and conditions as shall be determined by the members. A member may transfer his interest in the company as set forth in the Operating Agreement of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless a majority in interest of the members of the Company, other than the member proposing to dispose of his interest, approve of the proposed transfer by written consent, except as otherwise provided in the Operating Agreement.

#### **ARTICLE VI -- MANAGEMENT**






#### **ARTICLE VII -- RESIDENT AGENT ACCEPTANCE**
