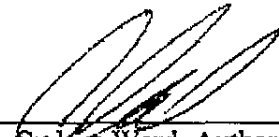

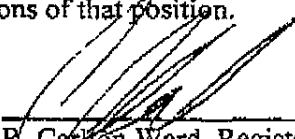
VI.
