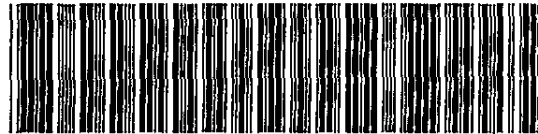




- FIRST: The Articles of Organization were filed on May 10, 2005 and assigned document number L05000048816.
