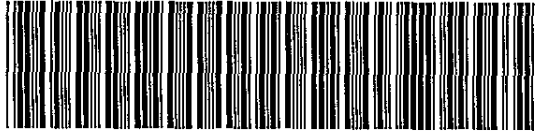

 - c. All other provisions of the Articles of Organization of Fast Foreign Exchange, LLC remain unchanged and in full force and effect.


RESIGNATION OF MANAGER
