ARTICLES OF ORGANIZATION OF

MOUSEMARKS, L.L.C.



These Articles of Organization of MOUSEMARKS, L.L.C., are being duly executed and filed to form a limited liability company pursuant to the Florida Limited Liability Company Act (the "Act").

Name
