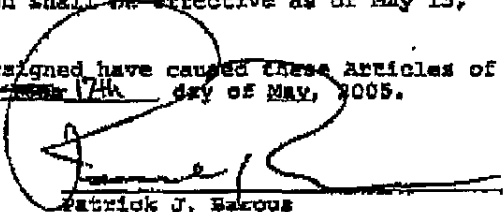
ARTICLE SIX
