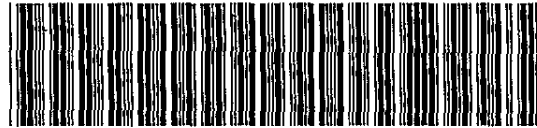


All the remaining property and assets of the Company have been distributed to the members.
