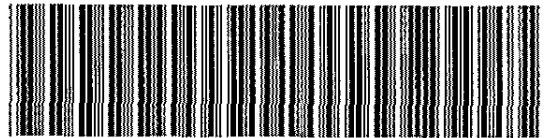

Additional members may be admitted with the approval of a majority in interest of the Members of the Company.

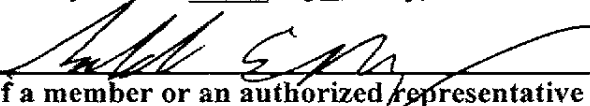
**ARTICLE VIII - Members Rights to Continue Business:**
