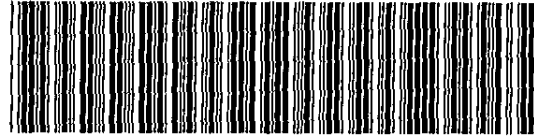

ARTICLE I
NAME

The name of this Limited Liability Company shall be **LONG LANDSCAPE SERVICE, LLC**.

ARTICLE II
DURATION

This Limited Liability Company shall exist perpetually from the date of filing with the Secretary of State of the State of Florida.

ARTICLE III
PURPOSE

TRANSFERABILITY OF MEMBER'S INTEREST

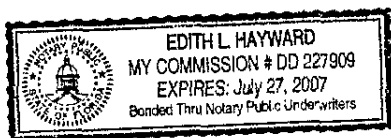

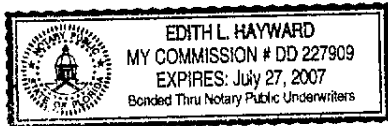



