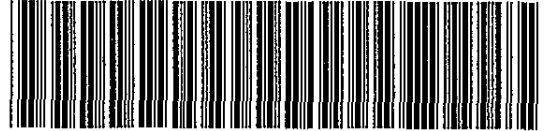

ARTICLE V- Purposes and Powers:


