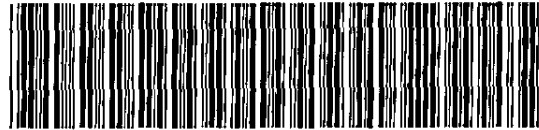

ARTICLE I

Name

The name of the Limited Liability Company is **C & C LTD. COMPANY.**

ARTICLE II

Address

The mailing and street address of the Company's principal office is 68 Par View Road,
Rotonda West, Florida 33947.

ARTICLE III

Duration

The period of duration of the Company is perpetual, beginning on the date these Articles
of Organization are filed by the Florida Department of State.

ARTICLE IV

Registered Agent and Office

ARTICLE V

Management
