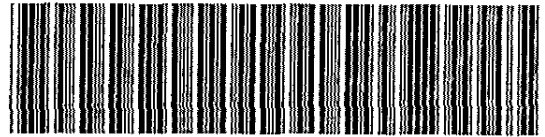

**ARTICLE I  
NAME**


**ARTICLE VIII**

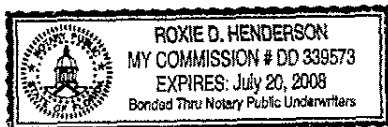


