ARTICLES OF ORGANIZATION

OF

ADDISION, DICUS AND FORD, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be ADDISION, DICUS AND FORD, LLC.

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the company is 315 N. Willow Avenue, Tampa, FL 33606.

ARTICLE III - DURATION
