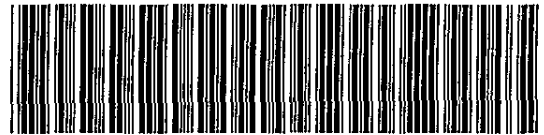

retirement, resignation, expulsion, or dissolution of any member or the occurrence of any
other event which terminates the continued membership of a member; provided,
however, that all remaining members may consent to the continuance of the Limited
Liability Company's business notwithstanding the death, bankruptcy, retirement,

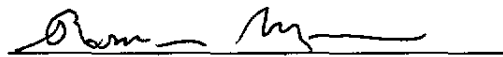
