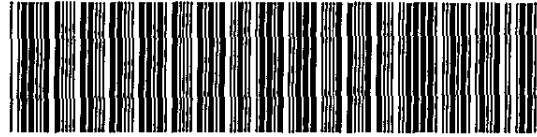

**ARTICLES OF ORGANIZATION
OF
THE ADVISOR GROUP OF FLORIDA, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be The Advisor Group of Florida, LLC ("Company").


ARTICLE IV -- MANAGEMENT
