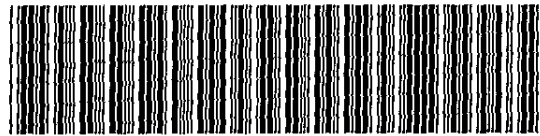




ARTICLE VI

Purpose and Powers


This Company is organized with a general business purpose, it has all powers provided by law and it may use those powers to any lawful purpose.
