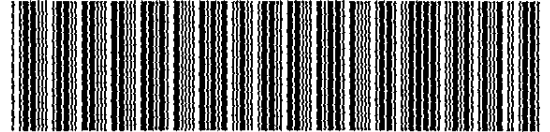




ARTICLE VI


