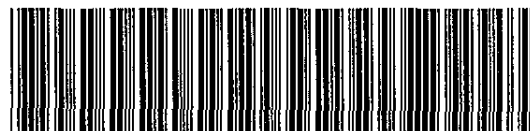



**ARTICLES OF ORGANIZATION OF
RICHIE'S BOAT REPAIR, L.L.C.**

ARTICLE I

Name


