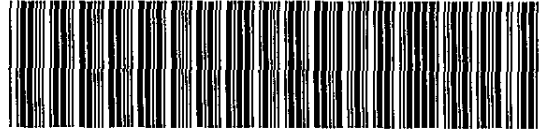




## ARTICLE VIII


