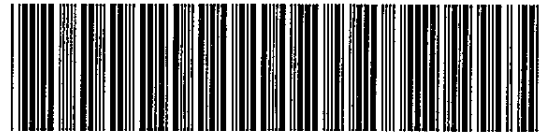

The mailing address and street address of the principal office of the Company is 95 Merrick Way, Suite 380, Coral Gables, Florida 33134.


ARTICLE III
