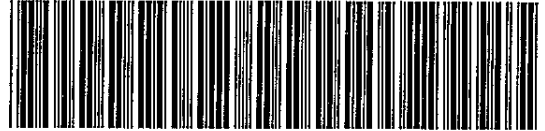

ARTICLES OF ORGANIZATION FOR
PROFESSIONAL SERVICE LIMITED LIABILITY COMPANY

(In accordance with section 608.408(3), Florida Statutes, the execution of this document constitutes affirmation under the penalties of perjury that the facts stated herein are true.)

ARTICLE V — INDEMNIFICATION

Except as expressly provided in the Operating Agreement, the Company shall indemnify its member, manager, or former member or manager to the full extent permitted under the Act.

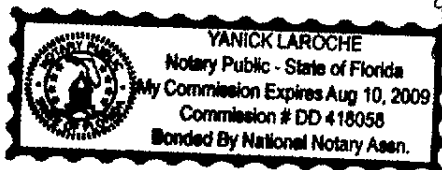

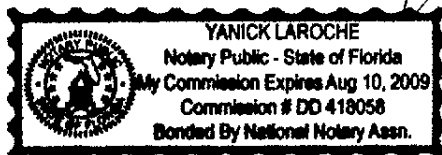
