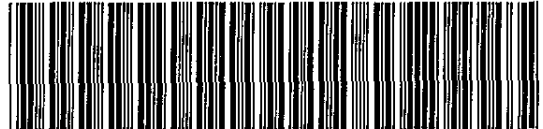

**NAME**

The name and address of the organizing Member executing these Articles of Organization is Elizabeth Gray, 6 Tomlinson Court, Cabin John, Maryland 20818.

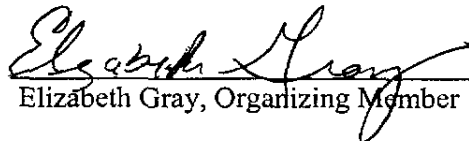
**ARTICLE VI**

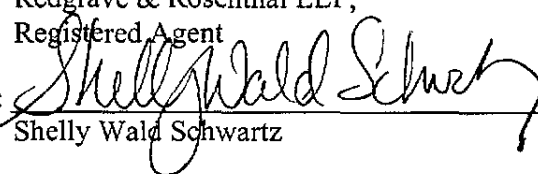
