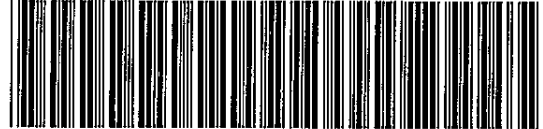


ARTICLE IV – MANAGEMENT


