The mailing address of the principal office of the company shall be P.O. Box 407, Ocala Florida 34478.


ARTICLE III - REGISTERED OFFICE AND AGENT

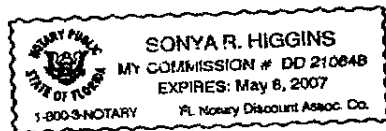

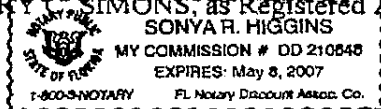
