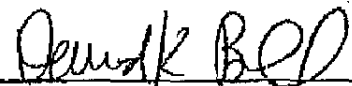
**ARTICLE VI**

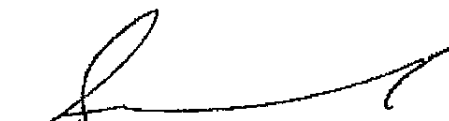
