ARTICLES OF ORGANIZATION OF CHRISTIAN FOREST MANAGEMENT COLL LAC 2005 HAY 17 P 12: 16

TALLAHASSEE, FLORIDA
The undersigned certify that for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. I further declare that the following Articles shall serve as the Charter and authority of the conduct of business of the limited liability company.

## ARTICLE I NAME, PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

- To exercise all or any of the limited liability company powers, and to carry out all or any of the purposes, enumerated in these Articles and otherwise granted or permitted by law, while acting as agent, nominee, or attorney-in-fact for any persons or corporations, and perform any terrect?: 16 under contract or otherwise for any corporation, joint stock company, entity, and in this capacity or under this arrangement develop, improve, stabilize, strengthen, or extend the property and to aid, assist, or participate in any lawful enterprise in connection with or render any other service or assistance it may lawfully do under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit.
