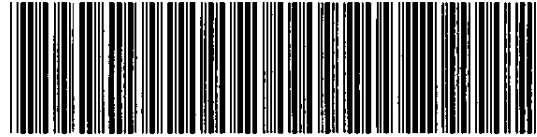

**SECOND:** The following amendments to the Articles of Organization and Operating Agreement were adopted by the manager-members of the limited liability company:


