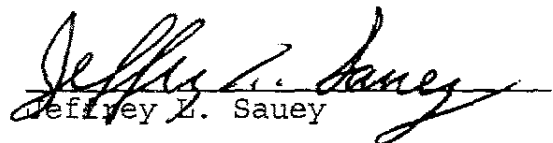

**ARTICLES OF ORGANIZATION OF
EVEREST HIGH, LLC**

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I - Name

The name of the limited liability company (hereinafter referred to as the "Company") is "EVEREST HIGH, LLC."

ARTICLE II - Address

The mailing address and street address of the principal office of the Company is 125 S.W. 11th Street, Ocala, Florida 34474.

ARTICLE III - Duration

The period of duration for the Company shall be perpetual.

**ARTICLE IV - DESIGNATION OF REGISTERED AGENT
INITIAL ADDRESS OF REGISTERED OFFICE**

The initial Registered Agent is designated as A. J. BARHOUSH. The Registered Agent of the corporation may be changed at any time by a vote of the Members without an amendment of these Articles.

The Company is to be a manager-managed company. The initial Manager is designated as ARAMCO, INC.

ARTICLE VI - Limitation on Agency Authority of Members

Pursuant to Section 608.4235 of the Florida Limited Liability Company Act, no member of the Company shall be an agent of the Company solely by virtue of being a member, and no member shall have authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a member.
