**ARTICLES OF ORGANIZATION
OF
COMPUTER EASE RENTAL, LLC**

The undersigned individual, acting as the authorized representative of a member under the provisions of Chapter 608, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I

Name

The name of this Limited Liability Company shall be **COMPUTER EASE RENTAL, LLC**

Principal Place of Business and Mailing Address

Name and Address of Registered Agent

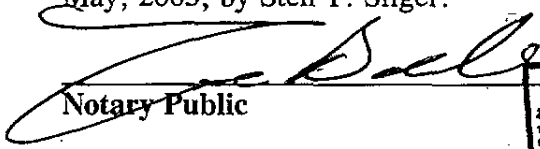

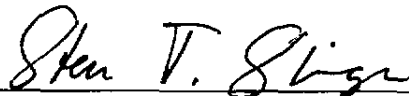
