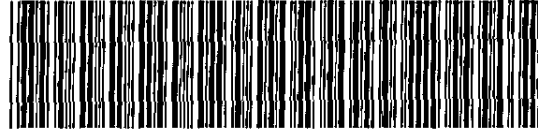

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be KINGSWAY LOAN GROUP, LLC ("Company").

**ARTICLE II -- ADDRESS**

The street address of the initial principal office of the Company is 109 Taylor Street - Suite 112, Punta Gorda, Florida 33950; and the initial mailing address of the Company is 109 Taylor Street - Suite 112, Punta Gorda, Florida 33950.

**ARTICLE III -- DURATION**

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State or on another effective date as specified. The Company's existence shall be perpetual unless the Company is dissolved earlier as provided in these Articles of Organization or in the Operating Agreement.

**ARTICLE IV -- REGISTERED OFFICE AND AGENT**

**ARTICLE V -- ADMISSION OF NEW MEMBERS**

Additional members shall be admitted to the Company only in accordance with the terms and provisions of the Operating Agreement. A member may transfer his or her interest in the Company only as set forth in the Operating Agreement of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless the Managers of the Company approve of the proposed transfer by written consent in accordance with the terms and conditions of the Operating Agreement.

## ARTICLE VI -- MANAGEMENT


The Company shall be managed by a committee of three (3) Managers, in accordance with the Operating Agreement for the Company adopted or approved by the members for the management of its affairs. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles. 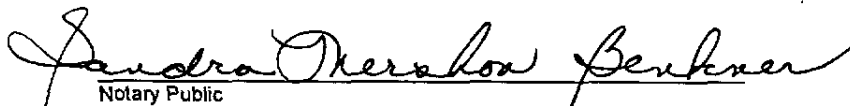
