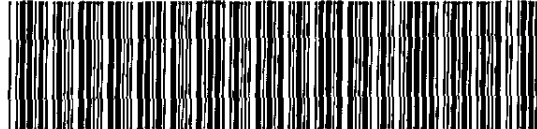

OF


