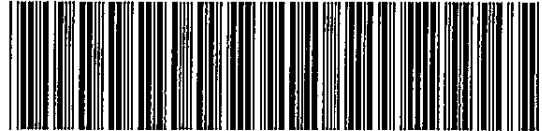

**ARTICLES OF ORGANIZATION
OF
ACLIN DEVELOPMENT LLC
A FLORIDA LIMITED LIABILITY COMPANY**

ARTICLE 1: NAME: The name of the limited liability company shall be Acline Development LLC.

ARTICLE 2: PURPOSE: The Company may engage in any lawful business.

ARTICLE 3: RESIDENT AGENT: The name and address of the resident agent is Peter J. Frabutt, 9220 Bonita Beach Road, Suite 105, Bonita Springs, FL 34135. The certificate of Designation of Registered Agent/Registered Office for the Company is attached hereto and incorporated herein as Exhibit "A".

ARTICLE 7: POWERS: The Company shall have all the powers authorized by law or statute.

ARTICLE 8: MEMBER LIABILITY: Members shall not be personally liable for the debts, obligations, or liabilities of the Company.

ARTICLE 12: CERTIFICATES: The Company has the authority and shall issue Certificates of Membership to each member evidencing that member's interest in the Company. Certificates of Membership shall be signed by the Managing Member of the Company.
