## ARTICLES OF ORGANIZATION

The undersigned organizer hereby forms a Limited Liability Company under Chapter 608 of the laws of the State of Florida.

#### ARTICLE L NAME

The name of the Limited Liability Company ("Company") shall be Grove Tactical Training & Survival Center, LLC.
