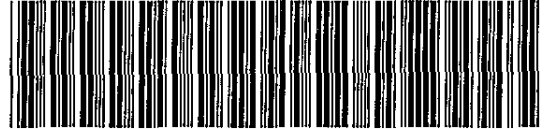

The name of the limited liability company is ROCK REALTY INVESTMENTS LLC (the "Company").

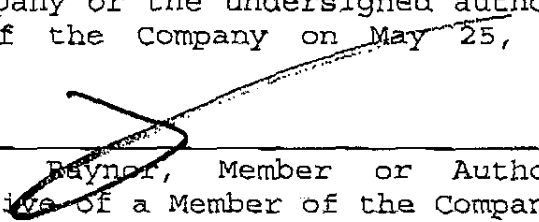
