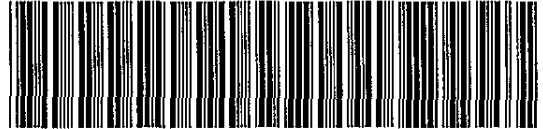


ARTICLE V






