THE UNDERSIGNED, under the Florida Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, hereby makes, acknowledges, adopts, and files the following Articles of Organization:

ARTICLE I - NAME

The name of the limited liability company is BERNADETTE DEVANEY, P.L. (the "Company").

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Company is 6040 Eagle Watch Court, Fort Myers, Florida 33917.

ARTICLE III - REGISTERED AGENT & REGISTERED OFFICE

ARTICLE IV - PURPOSE

Any member who becomes legally disqualified to render realtor services shall sever
