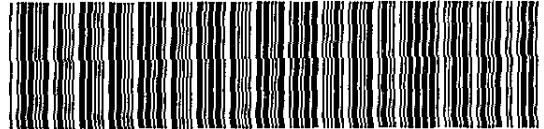



Continuation of Business




