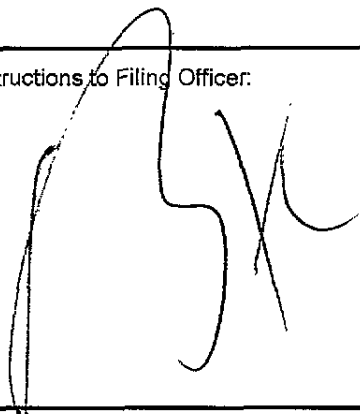

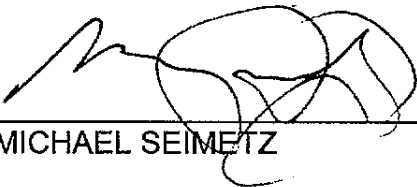
ARTICLE VI

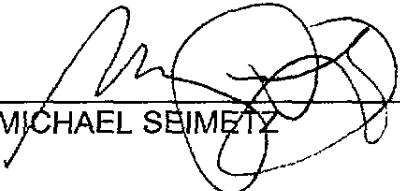
