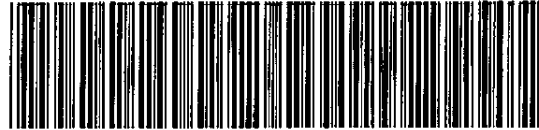

The principal place of business and mailing address of the Company is 161 16<sup>th</sup> Street, Atlantic Beach, Florida 32233.


**ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS**

The Company shall be a member-managed company as provided in the Operating Agreement.


