**ARTICLES OF ORGANIZATION FOR  
FLORIDA PROFESSIONAL LIMITED LIABILITY COMPANY**

THE UNDERSIGNED, under the Florida Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, hereby makes, acknowledges, adopts, and files the following Articles of Organization:

**ARTICLE I - NAME**

The name of the limited liability company is DON DEVANEY, P.L. (the "Company").

**ARTICLE II - ADDRESS**

The mailing address and street address of the principal office of the Company is 6040 Eagle Watch Court, Fort Myers, Florida 33917.

**ARTICLE III - REGISTERED AGENT & REGISTERED OFFICE**

**ARTICLE IV - PURPOSE**

**ARTICLE V - LIMITATION ON MEMBERSHIP**

No one other than an individual who is duly licensed or legally authorized to render licensed realtor services in the State of Florida or an organization described in Section 621.051 of the Florida Professional Service Corporation and Limited Liability Company Act may become a member of the Company. No member of the Company shall enter into an agreement vesting another person with the authority to exercise the voting power of any membership interest in the Company. Any member who becomes legally disqualified to render realtor services shall sever all employment with and financial interest in the Company. No Member of the Company may
