

#### ARTICLES OF ORGANIZATION OF DKAY STYLE, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I NAME

The name of the limited liability company shall be Dkay Style, L.L.C. ("Company"). The principal place of business of the Company in Florida shall be P.O. Box 5533, Lighthouse Point, Florida 33074.

The Company shall be dissolved upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or manager, or upon the occurrence of any other event that terminates the continued membership of a member of the Company.

# ARTICLE IX MANAGEMENT (MANAGEMENT BY MEMBER)

The Company shall be managed by the member in accordance with regulations adopted by the member for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
