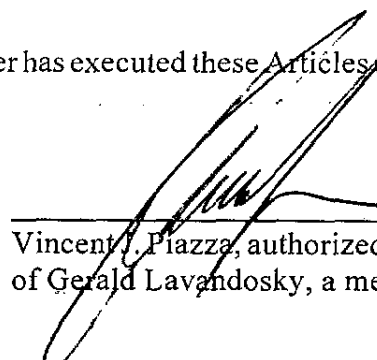
ARTICLE IX - Operation

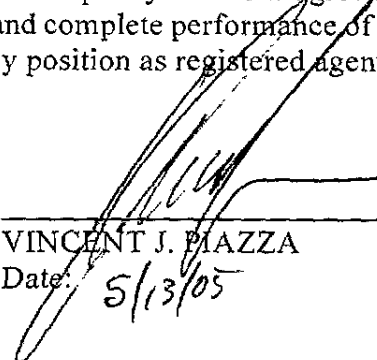
