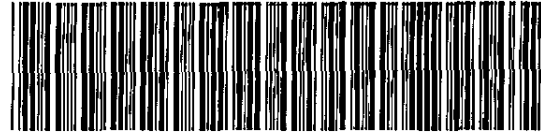


These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

1. Name. The name of this limited liability company is **Angher Home Inspections, L.L.C.** ("Company").
2. Duration. The Company shall exist from the date hereon until the occurrence of any of the events specified in Florida Statutes Section 608.441, unless continued by the unanimous consent of all of the remaining members.
2. Mailing Address and Street Address. The Company's mailing address is 4705 Sleepy Hollow Lane, Plant City, FL 33565. The Company's street address is 4705 Sleepy Hollow Lane, Plant City, FL 33565.
2. Registered Agent and Office. The name of the initial registered agent of the Company is **Frank J. Greco**. The street address of the initial registered agent of the company is **4047 Henderson Boulevard, Tampa, Florida**.
2. Additional Members. Additional members to the Company may be admitted, but only if all the current members agree to the admission of the additional members and to the terms of admission.
2. Termination of Membership. If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members may, by unanimous consent, continue the business of the Company. In addition, any member who fails to make a required contribution shall be required to sell his/her interest to the other contributing members pursuant to the terms of the Regulations.
2. Management of the Company. The Company shall initially be managed by Allen J. Ham who shall serve as manager until the first annual meeting of the members or until their successors are elected and qualify:
