

AMENDMENT OF ARTICLES OF ORGANIZATION**

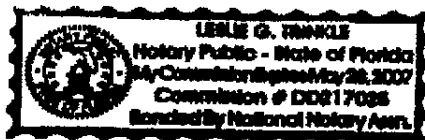


