**ARTICLES OF ORGANIZATION OF

The undersigned, HARRY B. STACKHOUSE, a natural person competent to contract and an authorized representative of a member of JAMES H. BRADLEY FAMILY, LLC, hereby presents these Articles of Organization as the Articles of Organization of JAMES H. BRADLEY FAMILY, LLC, a limited liability company formed under the provisions of Chapter 608, Florida Statutes.

**ARTICLE I - NAME**

The name of the limited liability company is:

JAMES H. BRADLEY FAMILY, LLC

This limited liability company is referred to in these articles of organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

The mailing and street address of the principal office of the Company is 3280 West Scott Street, Pensacola, Florida 32505.

**ARTICLE III - PURPOSES AND POWERS**

**ARTICLE IX - AMENDMENT**

Unless otherwise provided in the Operating Agreement for the Company, these Articles of Organization or any amendment thereto may be amended in accordance with the Florida Limited Liability Company Act.


