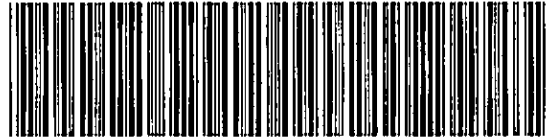




1. The name of the limited liability company is: WABASH INVESTMENTS, LLC.
