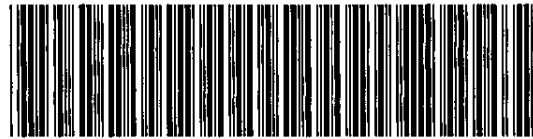

The date of the dissolution was effective September 25, 2012.


As of September 25, 2012, all members have resigned and pursuant to §608.441(1)(d), Florida Statutes, the limited liability company is thereby dissolved.
